

# BUD & MARILYN TUPPEN YOUTH FISHING FUND

---



This grant will provide up to \$2,000 to Palm Beach County based High School and University Fishing Clubs. Other organized youth fishing clubs and programs (Boy Scouts, Boys & Girls Clubs, Home School clubs, etc.) based in Palm Beach County are also eligible. The grant can be used to assist with club/organization expenses, such as the purchase of fishing tackle for awards, the purchase of fishing gear for participants, fishing charter fees, club t-shirts, etc. Applicants who demonstrate they are promoting ethical angling practices, supporting resource conservation efforts, and who are producing angling programs (tournaments, outings, meetings, etc.) are more likely to receive a grant. The amount awarded will be determined by the Grant Review Committee. Recipients must re-apply each year if in-

terested in receiving additional grants.

The grant application period is open year-round. Up to three (3) \$2,000 grants will be awarded during each funding cycle which runs from January 1 through December 31.
